

Dear Sisters and Brothers in Christ,

Perhaps you've heard horror stories about the terrible damage caused by identity theft. We work hard to protect our social security, credit card, and bank account numbers. We shred our financial papers. We keep a close eye on our purses. We might even sign up for identity protection services to protect against financial loss.

In the waters of baptism, Christ gives us our identity as children of God. His Father becomes our Father. The Father speaks to us the promise spoken to Jesus at his baptism in Luke 3:22, "You are my beloved Son; with you I am well pleased."

Once this promise is spoken, the devil immediately sets to work to steal our identity, so we forget who we are and whose we are. The devil especially likes to attack us during times of misfortune, when we are at our weakest. When we lose our job, when our health is threatened, when our family is breaking apart, when addiction wreaks havoc: this is when the devil tries to draw us into despair. During this time of pandemic, the devil considers us ripe for the picking!

In our suffering we are left asking, "If you really love me, Father, why are you allowing this to happen? Don't you care?" We may begin to assume, "I must not be the beloved child of God but forsaken by God."

Alternately the devil may tempt us with prosperity, drawing us into pride and self-sufficiency. He steals our identities as beloved child of God, offering instead identities based on riches, power, authority, honor, pleasure, or control over others. Such identities might be self-made man, pillar of the community, or Supermom. Our identities are then based upon what we do, not whose we are.

The devil can find some success in stealing our God-given identities, simply because we cannot (and in fact do not want to) believe that God's good pleasure comes apart from our actions. But the thing is that Jesus didn't come into the world for those who have it all together. As Jesus said, "Those who are well have no need of a physician, but those who are sick." Jesus didn't come for those who are winning the fight against temptation, because such a person does not exist. He came for the losers. Robert Farrar Capon wrote, "Grace doesn't sell; you can hardly give it away, because it only works for the losers and no one want to stand in their line."

For your sake, Jesus held fast to his Father's promise, resisting the devil's temptation. Unlike us, Jesus knew who he was and who's he was. Jesus is the Son of God, the beloved, with whom God is well-pleased. Jesus lived out that identity by doing the will of his Father for us. He humbled himself and became obedient to the point of death-- even death on a cross. Jesus bore our sins in his body on the cross and defeated them to set us free.

In your baptism, through Christ's death and resurrection, you were adopted by God. Your true identity - now and forever more - is beloved child of God, and it will never be stolen from you. God the Father is pleased with you for Jesus' sake.
