



Dear sisters and brothers in Christ,

Greetings! In *The Lutheran Difference Adult Study*, we have just finished up the second chapter on Law and Gospel. Luther, as a young monk, was acutely aware of what scripture had to say about his own sin and well-deserved condemnation, but he knew little of the comforting doctrine of God the Justifier and Savior. He came to know its comfort only after he had learned to distinguish between Scripture's two main themes: law and gospel. As Luther stated, "When I discovered the proper distinction – namely, that the law is one thing, and the gospel is another – I made myself free."

The Law shows us God's will and reveals our sin; the gospel proclaims our salvation in Christ. When we confuse these two doctrines, we remain confused about ourselves and about our God. Lutherans believe that the proper application of Law and Gospel is imperative, so that sinners are brought to repentance through the condemnation of the Law and are justified through faith in the promises of the Gospel.

We have been learning that the Lutheran interpretation of the Holy Scriptures, which comfort us and make us free, differs greatly from how other Christian denominations interpret scripture. As a result, our doctrines also differ. The most striking difference is in our understanding of salvation. Lutherans believe that salvation belongs to all who believe that Christ sacrificed himself on the cross for their salvation (the Gospel). The good news of the Gospel is that Jesus himself was born under the law, that he perfectly fulfilled the Law's demands in his earthly life, and that he suffered the condemnation of the Law in his atoning death. These things he did in our place, for our sake. This is our great comfort: all that we cannot do, Christ has done for us.

The Eastern Orthodox and the Roman Catholic Churches both teach that salvation ultimately depends on the Christian's obedience to God's law. This requires them to lower the requirements of the law, though Jesus commanded us in Matthew 5:48, "Be perfect, therefore, as your heavenly Father is perfect." And who of us is perfect? In this teaching, salvation is not assured, but it is a prize that must be earned.


The Baptists, Wesleyans, and Methodists teach that salvation ultimately depends on the Christian's decision to follow Christ. For these denominations, the obedience to the law has been lessened to a simple decision, sometimes called an altar call. And yet is not every decision that we make a choice between following Jesus and no following Jesus? Each time we get angry we are killing our neighbor in our hearts, which reflects that we are not, in fact, following Jesus. Jesus tells us clearly in John 15:16, "You did not choose me, but I chose you."

The Reformed and Presbyterian Churches teach that salvation is never certain, as it given only to the elect, those whom God has pre-chosen. In the *Canons of Dort* Article 12, members of the Reformed Church of America are encouraged to look for signs that they are elected "by noticing within themselves, with spiritual joy and holy delight, the unmistakable fruits of election pointed out in God's Word — such as a true faith in Christ, a childlike fear of God, a godly sorrow for their sins, a hunger and thirst for righteousness, and so on." So, feelings are the barometer used to know whether a person has been elected and will be saved, thereby offering no assurance or comfort.

Finally, the Liberal Churches, such as the United Church of Christ, Disciples of Christ, and Unitarians, believe that salvation pertains only to the betterment of this life. No assurance of eternal life or salvation is to be found in these teachings, therefore there is no comfort to be found either.

Each Sunday you are invited to worship to hear God's law to repent you and God's Gospel, which raises you up to new life through the forgiveness of sins. Through Word and sacrament, our Lord chooses you as his own and renews his promise that you live now and forever with him in eternal life. See you in church!


