Dear Sisters and Brothers in Christ,

Do you want to become one of the few, the proud, the Marines? If so, their initial strength test requires men to be able to do 34 pushups in under 2 minutes, run 1.5 in under 13:30, and hold a 40 second plank. If you can successfully complete that, you are fit to enter the US Marine Corps.

Do you want to become a St Paul Police Officer? If you are a man in your 20's, to pass the physical fitness test you need to be able to jump 21.5 inches in the air, do 37 pushups, and run 1.5 miles in under 14:43, plus your waist must be under 40 inches. If you pass that, you are fit to enter the St Paul Police Force.

But what if you want to enter the kingdom of God? What makes you fit for that? In Luke 9:62, Jesus tells us, "No one who puts a hand to the plow and looks back is fit for the kingdom of God." This is Jesus' response when a man says, in effect, that he will follow Jesus, but first "I just need to kiss my mother goodbye, then I am all yours, Jesus." It seems a reasonable request, and yet Jesus seems to be telling him that if he does, he's not fit for the kingdom of God.

Then we are filled with many questions. If this man had not wanted to bid farewell to his family, would he have been fit for the kingdom of God? Was Jesus putting forth some sort of litmus test to determine fitness? Are all the promises of God through Christ Jesus dependent upon our skill at plowing straight furrows?

This is where a little self-examination may prove helpful. Do you ever look back? Is your plowing always true and straight, perfectly focused on following Jesus? Perfectly living as a citizen of the kingdom of God?

Or do you get distracted by the things of this world? Does your head spin round with the works of the flesh mentioned in Galatians 5, "fornication, impurity, licentiousness, idolatry, sorcery, enmities, strife, jealousy, anger, quarrels, dissensions, factions, envy, drunkenness, and carousing," causing your furrows to be crooked when you put your hand to the plow?

With such a broad list, how can any of us fail to be convicted? The kingdom of God requires absolute perfection, without one flaw. No poor plowers allowed! Not even if you far outpace all the other plowers with your dedication. One glance back, one tiny bend in your furrow, and you are unfit.

After hearing Jesus' harsh words to this man, perhaps we are desperate to distinguish ourselves from him. We want to come up with proof that we aren't like him. We want to put as much distance between him and us as we possibly can. Or, failing that, we hope to show that at the very least we have great future potential.

But when we do this, we show that we completely misunderstand the gospel. Jesus has set his face towards Jerusalem because that is the only way that you and I can be made fit. In Psalm 129:3 Jesus says, "The plowers plowed on my back; they made their furrows long." As you and I put our hands to the plow and look behind us, our crooked furrows are dug deeply into Jesus' back. We carve our sin onto his flesh. As Isaiah 53 says, "...he was wounded for our transgressions, crushed for our iniquities; upon him was the punishment that made us whole, and by his wounds we are healed."

In Jerusalem, with the sin of the world carved upon him, Jesus was betrayed, arrested, flogged, mocked, and crucified. And this is precisely why God the Father sent only begotten Son, Jesus, into a world of crooked plowers – a world filled with people who are completely unfit for the kingdom of God. For our sake, Jesus plowed a perfectly straight line all the way to the cross, so that our crooked furrows will not be held against us and so that we will not remain unfit and forever outside the kingdom. He passed the fitness test by his death and resurrection, making you fit for the kingdom of God through the forgiveness of your sins. This means that yes, indeed, you will follow Jesus wherever he goes!

Join us each Sunday as we hear the Good News of how Christ makes us fit for his kingdom! See you in church!


