Pastor Carl led the group in prayer. M/S/P to accept the Consent Agenda. M/S/P to approve the Secretary's Report of the June 12, 2024 meeting. M/S/P to approve the Financial Statement as printed.

Pastor's Report

- •Conducted memorial service for Dalores Stern.
- •Conducted pre-marriage counseling and weddings for Tyson & Samantha Meidl and Russell & Sharon Rogotzke.
- •Conducting midweek services on Tuesdays at 6 p.m. in the chapel. Average attendance is 10 with people from St. Paul's and St. Johns attending. Will probably not continue the services in the fall.
- •Conducted four in-home communions, hospital visits and counseling sessions.
- •Participated in the Mutual Ministry team meetings with St. Johns and St. Paul's.
- Participated in Transition Team meeting August 13. Many of the goals are on their way to being accomplished. Working on Fellowship groups and revitalizing our Work (Servant) Groups—possibly through a Stewardship Program in November.
- •Invited to be one of the speakers at the LCMC Retirement Retreat August 26-29, 2024.
- •Preparing for Confirmation Classes. Will be held at St. Johns Church as that is closer to the school and students can enjoy the Table Ministry Meal before class begins each Wednesday night.
- •Will be out of town September 2-6.

Intentional Interim Contract


•M/S/P to move the contract from ¾ time to full time beginning September 1. The extra work load with Confirmation and agreeing to be pulpit fill at St. Johns Church is the reason for the change. Will visit with St. Johns Church to see if they will help with the compensation change.


Parish Education

- •Sunday School staff is in place for the coming year. Rooms have been assigned and Memory Work determined for the year. A Teacher Meeting will be scheduled for August 28.
- •Sunday School will begin on September 15. Rally Sunday will be held in Riverside Park September 8 with St. Johns Church. Worship will be at 10:00 a.m. followed by donuts and coffee.
- •Student presentations will be as follows: Cradle Roll Doves and Kindergarten Bibles on September 22; First Grade Catechisms on September 29; and Third Grade Bibles on October 6.

Old Business

- •Work on area under ramp by Salonek's has been completed.
- •Schmidt Brothers completed the roof projects at the church and the parsonage.
- •Parsonage window and paint repair from hail damage will require photos and quotes submitted to our insurance company. The damage was due to hail last October. Will get quotes from Lowell Helget for window repair and Neil Neidt or Vogel's for painting.
- •Decided no action is needed for any tree removal on the parsonage property at this time.
- •The Community Picnic on August 6 was a big success. Approximately 500 people were served. Discussed the possibility of making it an annual event to include all the other local churches.
- •Combined Worship Services with St. Johns began August 11. Will be at St. Paul's August 18 and then at St. Johns August 25 and September 1.
- •Stewardship Campaign was discussed. It has been some time since our congregation actually had a campaign. Will make it similar to the former "Thanks for





- The Mutual Ministry Team of St. Paul's and St. Johns met July 15 and August 4. The August 4 meeting was called by the Church Council of each congregation with a purpose to develop guidelines if our two congregations would share a pastor. Council looked at the guidelines and agreed they should be communicated to our congregation—possibly with a congregational meeting. Pastor Carl has communicated with St. Johns fill-in Pastor and there is interest by that pastor to serve both congregations.
- The Call Committee has been meeting. They have reached out to possible candidates with not a lot of response.
- •The committee for the updates to the Sunday School rooms/fellowship hall/ sanctuary has begun work in the Sunday School rooms. Al Groebner has been doing a lot of the work. Plans are to paint, new chairs, new window coverings and new equipment for each room now being used. M/S/P to let the committee continue with their plans with expenses not to exceed \$10,000.
- •Discussion on the church's water softener. Currently we are paying Culligan \$150/month or \$1800/year for service and the equipment is out dated. M/S/P to purchase a new Select Plus Softener from Culligan for \$2,345 with free softener salt for one year.

New Business

- •M/S/P to hold our Fall German Supper on Wednesday, September 18. More details to follow.
- •M/S/P to hold the Church Auction on Sunday, October 13 following the worship service. The event will include a luncheon. Kathy Pederson and Angel Rummel are heading up the Auction.
- The Scholarship Committee recommends \$500 scholarships to the following applicants for the Good Shepherd Scholarship: Brendon Buerkle, Courtney Wendt, Carter Asmus, Jordyn Plaster and Kyler Zihlke. M/S/P to accept the recommendations.
- Schmidt Brothers Roofing has requested the use of our church parking lot for a

customer appreciation lunch 11:30 a.m. to 1:00 p.m. August 29. They did a lot of business in the community following the October hail storm (including our church and parsonage) and wants to thank everyone for their patronage. M/S/P to allow use of our parking lot August 29. St. Johns Church hosts a weekly Kitchen Table Ministry each Wednesday at their church. They offer a meal, free-of-charge, for anyone who would like to attend. They have asked if our church would like to be involved and possibly do the meals two times during each month. Our church is not ready at this time to offer services for two times per month but will continue to discuss it.

 Summit Fire Protection was out to inspect the fire protection equipment in the church kitchen. There are some items that are not up-to-date and did not pass inspection. A quote of \$2300 was given by the company to bring things up-to-date. Due to the importance of this fire safety issue, we will proceed once Al Groebner and Randy Wendt look at the equipment and what is proposed. M/S/P to proceed. Discussion on the Bell Choir. The Bell Choir has not practiced or performed for almost two years. There has been some interest in getting it started again. There is a need for a director. Jeff Krueger is not interested in directing the Bell Choir. Will advertise for the position. How would we proceed if someone from outside our congregation would like to be the director? There will be further discussion next month.

We closed with the Lord's Prayer. M/S/P to adjourn at 9:10 p.m. Next meeting will be Wednesday, September 11 at 7:45 p.m.
